This shall be the case no matter where the property is located, and whether in storage or operation, moored or docked, as long as it shall be in the possession of Harborside Marina, and whether within or without the storage period above provided for and does not carry any insurance for the same. Furthermore, I agree to insure this property for the period of this contract and keep a current binder on file with the marina office.

The owner further agrees that Harborside Marina shall not be liable for any loss, damage or destruction to dishes, bedding, clothing, fishing gear, electronic equipment or any other article not physically attached to the boat and used in its operation, no matter how caused.

Any damage caused by Harborside Marina's employees either by accident or negligence, will be the responsibility of Harborside Marina and/or their insurance carrier.

I understand by signing this contract, all repair orders given over the phone are binding to this contact. I also agree to the rules and regulations on the reverse side of this contract and my signature acknowledges my acceptance of these rules. Faxed contracts are binding. Please note, maintenance plans do not include detailing, teak or bright work, or gasoline.
